Lawson Way project

The following articles were presented at the last club committee meeting, the first by the Hon treasurer, Peter Metcalfe. The second is from committee member Peter Costello. INSPIRED FACILITIES (IF) SUBMISSION: SECOND ROUND FEBRUARY-MARCH 2012

The maximum amount of money available to us under IF is £50,000. This includes any VAT we have to pay. If the project exceeds that then an explanation must be given as to where the balance is to come from. The grant is withheld until the balance is confirmed. The current proposal for B range has been costed and comes to £93,310 excluding VAT (see attached). For a bid submission cost estimates have to be formal. In the absence of awareness on my part of any other substantive funding sources no valid statements regarding the balance could be made and therefore the bid was not submitted (closing date 2 April). The next round opens on 23 July with a closing date of 17 September.

The following options are available on the assumption that the steady work on A range continues using our own resources, whatever the NRA might offer in the way of a loan which is acceptable to us, and what we can beg, steal or borrow:

Options for B range

1. Try again in the next round and hope to be able to answer the question regarding cost mismatch in substantive terms.

For: # less rushed bid

Against: # unlikely to be able to answer the question anyway

2. Carry out a second review of the costs for the B range works to see if any further savings can be made (bearing in mind that applications must be accompanied by properly constituted cost estimates) and submit for the next round.

For: # costs reviewed and double checked

Against: # unlikely to bring about the substantial reduction needed.

3. Reduce the costs by removing the capability for firearms use, reclassify B range for archery / air rifle / air pistol / soft air use only and reconfigure the B range scheme accordingly

For: # better chance of a sub £50,000 result due to a much simplified scheme

problems from mixing lead generating use with non lead generating uses avoided

B range brought on stream for wider use (and revenue generation) sooner

rather than later
keeps faith with the local community groups

Against: # no firearm use on B range for the foreseeable future

4. Put B range conversion in abeyance until A range completed

For: # concentration on A range, no distractions

Against: # Lose any chance of IF funding until at least 2013/14 (fourth and fifth (final) bids)

costs equation still the same

no definite timetable for the completion of A range

if we are unable to bring B range on stream, or if there is a substantial delay, this will lose revenue and be seen as a breach of trust by local community groups.

5. Put the above options (and any others) to an EGM.

Lawson Way at a Crossroads

Those of you who attended the AGM will have heard me say that we intended to create two firearms ranges at Lawson Way and that we were applying for grants. The NRA cannot offer us a grant but have offered us a very low or no interest rate loan subject to us having suitable security.

We have carried out a full cost estimate for B range based for a grant application for which the maximum amount of money available would be £50,000. The cost estimate comes out in excess of £93,000 and to qualify for the grant if it were to below the required amount we would have to prove our ability to provide the shortfall. We could only find the shortfall by borrowing and, since the nature of our sport makes it one that could be banned at any time, asking club members to give surety to such a loan would be something none of the committee would like to consider. It is with reluctance that we have to accept the fact that, if we obtained the maximum grant, we would not be able to find another £43K (or more!) to pay for the completion of B Range. Club members cannot carry out the work if we are grant aided so we cannot cut corners to reduce the bill. If we were to get a relatively small loan then it would have to be to help us with A Range since we need our own indoor facility.

It is our aim to turn Lawson Way to be a centre of excellence for target sports in the North East but we have no way of getting the cash to do everything. This brings us to a crossroads.

The option we thing is the best one to select at this time is to reduce the scope of B Range for the grant application and make it non-firearms i.e archery, air pistol, air rifle & airsoft. If we opt to make B Range a non-firearm facility then the costs are reduced thus

- we do not have to build a range with three layers of cement blocks in order to insulate against sound
- we do not need a suspended ceiling
- no need to have intensive extraction
- reduced heating requirement for B range
- no backstop

The plusses

- a reduced scheme makes the project more attainable
- we can get sports members into the club to generate revenue
- we could segregate the accesses for A Range and B Range to allow the B Range to be used whilst construction of A Range continues
- the internal wall height can be raised
- we would have power, toilets & kitchen access for both ranges within the grant amount
- we would not risk confrontation with sports members about the risk of lead poisoning.

The significant minus is that we would only have one range for firearms, contrary to what we have always said we intended to do. If we were to get the grant and have the range build as a non-firearms range then we would not have the option to convert at a later date as this would involve closure and dismantling of a significant portion of the building which would prevent members from using the facilities for a long period.

However, we still need to apply for the grant with the reduced scope B range and there is no guarantee that we will get the money. If we get the grant then we continue with A range construction as we have been doing so far (and we still need your help folks). If we do not get the grant then nothing will have changed end we continue with A range construction.
